	September 30th	Begin working on <b>Senior Brag Sheets</b> in Naviance. These are used by your counselor for scholarships, letters of recommendation, etc.

	October 1st - November 30th	Initial filing period for Freshman CSU applications for fall 2020 admissions Apply on-line at: <a href="http://www2.calstate.edu/apply">www2.calstate.edu/apply</a> Must send applications to each campus that you want to apply to: <u>\$55 per campus</u>
	October 3rd	Registration deadline for November 2nd SAT I Reasoning Tests and SAT II Subject Tests (Collegeboard.org)
	October 8th	Covina-Valley Unified College Fair 5:00 - 7:00 at District Field. Great opportunity to ask questions of college representatives.
	October 16th	SAT School Day
	October	Cash for College Event at Mt. Sac. FREE Financial Aid Assistance (FAFSA & CA Dream Act. Must register at <a href="http://www.mtsac.edu/financialaid">www.mtsac.edu/financialaid</a> )
	October 26th	ACT Assessment plus Writing Test

	<b>November 26th</b>	Late registration for Dec. 7th SAT I Reasoning and SAT II Subject test
	<b>November 30th</b>	Deadline: UC/CSU application must be submitted by 11:59 pm PST
<b>DECEMBER</b>	<b>December 7th</b>	SAT I Reasoning Test and SAT II Subject Tests date (last test date for Fall 2020 freshman applicants)
	<b>December 14th</b>	ACT Test date (last date for fall 2020 Freshman applicants to take test)

	<b>January 31st</b>	<b><i>GPA Verification Form required for Cal Grant consideration must be turned into Mrs. Friedel, CHS Registrar, by January 31st - one month ahead of state deadline.</i></b> This form was part of your registration packet and should have been submitted in August. If you are unsure see Mrs. Friedel. Information on CAL Grants: <a href="http://www.csas.ca.gov">www.csas.ca.gov</a>
<b>FEBRUARY</b>	<b>February 1st</b>	Check status of your applications. Watch for an application acknowledgement that your applications and fees have been received (generally four to five weeks after you submit your application)
		Community College applications for Summer and Fall of 2020 Check in the Counseling Office or the College & Career Center for Citrus & MSAC on campus meetings and placement testing
<b>MARCH</b>	<b>March 1st-31st</b>	Notification of fall 2020 admission decisions
	<b>March 2nd</b>	Deadline for applicants for all terms to submit FAFSA, California Dream Act Application and GPA Verification Form.
<b>MAY</b>	<b>May 1st</b>	Deadline for fall 2020 admitted freshman to submit the <u>Statement of intent to Register</u> to their chosen campus
<b>JUNE</b>	<b>Prior to graduation</b>	See Mrs. Friedel, CHS Registrar to request final transcript be sent to your college of acceptance
