Dear Parent

Covina-Valley Unified School District will continue to participate in California's *School District of Choice Program* permitted by Education Code 48300 through 48317 as established in SB 680, the "School District of Choice" Bill. Since C-VUSD is a "School District of Choice," **any parent or guardian who does not live within C-VUSD school district boundaries and is interested in having their child attend C-VUSD schools entering grades TK-11 will not be required to be released from their district of residence if they apply for, and are accepted to, our District of Choice program.**

2022-23 District of Choice applications MUST be completed and submitted to the Covina-Valley Unified School District between October 15, 2021, and December 10, 2021. You do not need to be released from your district of residence to submit your application and be accepted. Please return the application either via email to Ingrid Alvarez at ialvarez@c-vusd.org or via U.S. mail (**postmarked no later than December 10, 2021**) to: Covina-Valley Unified School District, Student Services (ATTN: DOC), 519 E. Badillo St., Covina, CA 91723.

2022-2023 District of Choice applications will NOT be accepted if hand-delivered or postmarked after December 10, 2021.

Also, note that we are unable to accept applications for students from the following districts:

Pomona USD, Rowland USD, Charter Oak USD, or Azusa USD

If the number of 2022-2023 applications exceeds the number of available spaces in the Covina-Valley Unified School District, a public lottery drawing will take place on January 14, 2022. If the number of 2022-2023 applications does not exceed the number of available spaces, all applications received by December 10, 2021, will be accepted for admission by the Board of Education on January 18, 2022. Letters will be mailed out by the second week of February 2022 with *tentative* school assignments. **PLEASE NOTE: School assignments are based upon space availability. Your school assignment is subject to change through August 22, 2022.**

Late applications will not be accepted – no exceptions! Any applications received after the December 10, 2021 deadline will NOT be considered for the 2022-23 District of Choice enrollment.
