DUTIES AND RESPONSIBILITIES OF SCHOOL PSYCHOLOGIST

Primary Function

The School Psychologist is responsible for providing psychological services that will assist students, teachers, parents and other staff members in the management of learning and behavioral disorders in order that all students will be able to make optimum progress toward the attainment of District goals.

Duties and Responsibilities

The School Psychologist:

- 1. Consults with principals and other staff members to develop and implement preventive programs, research and evaluation activities, staff development activities and parent education activities;
- 2. Receives psychological referrals, observes students in the classroom, reviews school records and makes preliminary interpretations and recommendations from these findings to the staff;
- 3. Consults with principals, teachers and guidance team members regarding interventions for children with learning and behavioral disorders;
- 4. Interviews parents and conferences with them regarding difficulties their children may be having in school;
- 5. Administers and interprets psychological tests;
- 6. Acts as a case carrier and prepares reports;
- 7. Participates as a member of the IEP teams in the identification, placement, review and dismissal of students from special education programs and services;
- 8. Counsels with individual students or with groups of students as appropriate;
- 9. Makes referrals to community agencies for the care and treatment of specific non-instructional problems;
- 10. Participates in professional development activities as assigned;
- 11. Assists the supervisor in carrying out other duties and responsibilities as directed;

- 12. Adheres to the policies of the Board of Education, the laws and regulations of the California Administrative and Education Codes and other applicable laws and regulations; and
- 13. Participates cooperatively with the evaluator to implement the procedures by which he/she will be evaluated in conformance with the District's uniform guidelines for certificated personnel evaluation and assessment.
